Pursuant to Illinois law you waived your right to contest the violations when you failed to request an administrative hearing within the time period provided by law.

Pursuant to the Illinois Administrative Code (Title 92, Section 2520.750(b)) payment is due within fourteen (14) days. Payment extensions or payment plans will not be considered.

Failure to pay the above amount in-full by the due date may result in all of the following:

- escalation of the total fine to Seventy Dollars (\$70.00) per violation;
- filing of a Certified Report to petition the Illinois Secretary of State for suspension of the respondent(s) vehicle registration and/or driver's license under 625 ILCS 5/3-704.2 and 6-306.7 for 5 or more violations; and
- forwarding of the matter to a private agency or law firm for collection action.

This final administrative order may be appealed to the 18th Judicial (DuPage County) Circuit Court of Illinois under the Illinois Administrative Review Law within thirty-five (35) days of the issuance date of this order. Pursuant to 735 ILCS 5/3-102 the legal grounds for administrative review are limited to questioning personal or subject jurisdiction.

Call 1-800-824-7277 / 1-630-241-7302 - T.D.D. and a representative will assist you. Please have your I-PASS account number, notice number and license plate number available when you call. You must resolve this matter by the due date of this notice or you will be held liable for all tolls, fines and fees as per the Illinois Tollway I-PASS Agreement.
